#### ARTICLES OF INCORPORATION

OF

#### SPRING CREEK FOREST CIVIC ASSOCIATION

We, the undersigned and natural persons of the age of twentyone years or more, at least two of whom are citizens of the State
of Texas, acting as incorporators of a corporation under the Texas
Mon-Profit Corporation Act, do hereby adopt the following Articles
of Incorporation for such corporation:

#### ARTICLE I

#### CORPORATE NAME

The name of the corporation is SPRING CREEK FOREST CIVIC ASSO-

#### ARTICLE II

#### CORPORATE STATUS

The corporation is a non-profit corporation.

#### ARTICLE III

#### DURATION

The period of its duration is perpetual.

#### ARTICLE IV

#### PURPOSES

The corporation is formed for the purposes of promoting the health, safety and welfare of the residents and property owners of SPRING CREEK FOREST, a subdivision of several Sections in Harris County, Texas, controlling and administering the Annual Maintenance Fund in accordance with Restrictions, Covenants, Conditions and Assessments for SPRING CREEK FOREST SECTIONS duly recorded, and having and exercising any and all powers, rights and privileges which a corporation organized under the Non-Profit Corporation Act of the State of Texas may by law now or hereafter have or exercise; provided that none of the objects or purposes herein set out shall be construed to authorize the corporation to do any act in violation of said Non-Profit Corporation Act or Part Four of the Texas Miscellaneous Corporation Laws Act, and all such objects or purposes are subject to said Acts.

#### ARTICLE V

#### ARTICLE VI
